The Ingham County Potter Park Zoo Advisory Board held a regularly scheduled meeting in the Potter Park Zoo Discovery Center Safari Room.

**CALL TO ORDER:** Chair John Groen called the regular meeting of the Ingham County Zoo

Advisory Board to order at 6:01 p.m.

### FINANCIAL REPORTS

#### **Zoo Financial Report**

Director Wagner reported third quarter budget adjustments should be reflected in November's financial report which will include a significant adjustment for the cost of the point of sale system. Estimated use of fund balance for 2020 is approximately \$700,000, leaving the fund balance with approximately \$250,000. Director Wagner stated final numbers depend on expenditures for the remainder of the year since most revenue has been recognized. Chair Groen asked how she felt 2021 would go if the situation stayed as it has been. She stated if the zoo can stay open that she does not foresee a problem with admissions, but there would likely be a drop in revenue at the Grill and AniMall due to lack of school groups.

Director Wagner stated a golf cart was stolen from in front of Pavilion 2 and will be replaced with insurance funds. A police report was filed and surrounding areas including the river had been searched.

Chair Groen commended Director Wagner on doing a nice job managing the zoo during this time.

Mary Leys asked if the fall event has been well attended. Director Wagner stated that it has been well attended, but with capacity limits we will not come close to past Boo at the Zoo numbers. Julie Pingston shared funds were donated by Meijer for the purchase of donuts from Groovy Donuts. There are two weekends left for the event.

#### **ZOO DIRECTOR REPORT**

Chair Groen asked how capacity limits had affected overall admission numbers. Director Wagner stated that there were only a couple of days in 2019 that admission numbers exceeded the maximum capacity number so she did not believe attendance had been negatively affected by the cap.

Winter hours change Nov. 1 and rates will drop to \$4 for adults and \$3 for children.

College Day was not advertised this year, but also was not cancelled. There were 25 students that came to the zoo.

The six-week management course through Davenport College started. This course was paid for by Ingham County and appears to have very helpful content over six weeks.

The braille map has been installed. After the press release an inquiry was received by a member of the public whether we had braille restaurant menus. There are not currently braille menus, but we will create them without prices because prices changes frequently. These will be maps printed on paper that will be checked out with the portable braille zoo maps.

Sarah Foote is coordinating two SSP programs as well as a studbook for Blanding's turtle. She received an award from the Population Management Center for her work. This is the most a PPZ employee has been involved in the population management side of AZA and Sarah is doing a great job.

The revenue management system is working very well in the gift shop and restaurant. There are many things that still need to be learned about reporting.

The Savanna Grill health inspection recently took place and there were no violations. Jon Lawrence had met with the department earlier in the season to revue COVID requirements which helped the zoo navigate all of the new protocols.

FALCONERS will be virtual in the month of November.

There is not a date set yet to bring back the education staff that are furloughed.

There are many changes that we are working towards in the education department for the program animals. All animals will be trained to allow for choice and control which is in keeping with the AZA program animal standards. Plans are being developed to make sure every guest that comes to the zoo is educated. Every animal at the zoo is here for education and staff and volunteers need to adapt to that mindset and get creative with how to utilize exhibit animals for education. It is possible to make these changes because of the lack of programming. Chair Groen stated that it is disappointing to not have school groups, but it is good to use this time to make necessary changes.

The Society is working with the Non-profit Network with grant funds awarded by the Capital Region Community Foundation on capacity building and diversity, equity and inclusion efforts.

Rick Parker, Sarah Foote and the Director met with a member of LPD to talk through emergency protocols with a focus on evacuation.

Phineus had a physical that was extremely well coordinated by Dr. Ronan. His semen was collected for a research project as well as other testing.

Tala, the female wolf, has cancer and treatment options are being discussed. She is an older animal.

Kaiti worked with keepers to create behind the scenes videos of red panda and rhino care for the Conservation Days.

A member of the public contacted Amy Sunday, Oct. 11, 2020 about a racist piece of mail she received. The woman received a picture out of a Jane Goodall calendar that had her name on it and the return address on the

envelope is the zoo address. There was no other correspondence just the picture. Amy informed her that the zoo would never condone any racist message and that any correspondence sent by the zoo would have a typed address and letter explaining the reason for the correspondence. The woman believed we had not sent the letter and she agreed to notify us if anything further was received. Dr. Snider suggested documenting the situation.

The response to an anonymous letter received by Director Wagner was that the zoo UAW Unit Chair would hold interviews with all UAW zoo members giving the opportunity to voice their concerns anonymously. This was completed, and Director Wagner received a summary of the anonymous complaints which state the Animal Care Supervisor is a poor supervisor in the manner he treats the keepers and that he spends too much time with certain keepers and shows them favoritism. The major complaint against Director Wagner is that she does not hold him accountable for his actions.

Animal welfare complaints listed fell under two categories including time to complete work and having a keeper on the animal management committee. Area leads will now be welcome to attend all animal management meetings to represent their prospective areas. There is a lot to dig into to work through the time concerns. There is a feeling that we have too many animals compared to the past. Sarah Foote completed an assessment of animals and species over the past decade and the numbers do not show we have more animals. If this is the perception, then we need to find out which animals keepers feel are taking too long.

Conversations that result in action items will be documented via email and all communications that need to go to all keepers will happen via email to maintain clear communication.

A meeting will be held with the keepers October 20, 2020 to share the action plan that is a result of the feedback. Sue Graham is planning to attend that meeting.

Chair Groen thanked Director Wagner for her transparency. He asked how the zoo determines staffing levels for industry standards and suggested using those resources to evaluate staffing. Director Wagner replied that the inspectors had noted sufficient staffing during their last inspection. Chair Groen suggested looking at 360 feedback which includes peer to peer feedback. Mary Leys agreed this could be helpful to make sure management is getting the full picture.

### **NEW BUSINESS**

### Resolution - Agreement with City of Lansing for River Trail Maintenance

Director Wagner shared this was an agreement that was in place already that she was not previously aware of. She explained that as a result of this agreement the zoo would do basic maintenance for the section of the river trail between Pennsylvania and Mount Hope.

Moved by Julie Pingston and supported by Mary Leys to approve the Resolution as written, **Yes-7**; **No-0**; **MOTION CARRIED**.

### Director Report November 18, 2020

I will have completed a six-week course, Certificate of Management Institute for Professional Excellence at Davenport University Nov. 19, 2020. This was a very informative and beneficial course to enhance management skills.

AZA released a diversity statement. The full position statement is included at the end of this report.

### **Safety**

- The Emergency Response Team will participate in firearms training led by the Ingham County Sheriff's Department Nov. 17, 2020.
- Staff injuries were down 25 percent in 2020 for the same time period as 2019.
- We continue to use near miss forms to document safety issues that could have resulted in injury or a safety incident. Managers and the safety committee address the near miss to prevent injury or incident from occurring in the future.
- The flu clinic was a success. Thirty-three people received their flu shots at the zoo compared to 15 people last year

### **Staff Engagement**

- A pumpkin decorating and costume contest were held Friday, Oct. 30 for all staff. Goodie bags and prizes were provided by Rick Parker and Cindy Wagner for the participants. All staff were encouraged to join in the fun even if they did not enter a pumpkin or wear a costume.
- Tuesday, Nov. 17, is crazy sock day for all staff. Everyone is encouraged to wear their craziest, family friendly socks to work that day and show them off.
- The new male bongo did not arrive with a name. We will be asking all staff to participate in naming him by selecting several names and asking staff to vote via survey monkey.

### **Guest Services**

- Lattes and Cappuccinos are now available at the Savannah Grill.
- The AniMall is open from 10 a.m. 4 p.m. daily. The Savannah Grill is open weekends from 10 a.m. 4 p.m. Both the AniMall and the Grill will be open during Wonderland of Lights.
- Wednesday, Nov. 11 was Veterans Day and all members of the military and their families received free admission to the zoo. We had seventeen guests use this incentive.

### **Society**

The Michigan Council for Arts and Affairs awarded the Society \$18,000 to assist with day to day operations. Erin O'Rourke and Dennis Laidler did a great job with the application.

We saw about 6,000 guests over the three Fall Zootacular weekends! It's not the admission numbers we'd have during a typical Boo at the Zoo season, but the Society is thankful we could have a fall event this vear.

FALCONERS Fall Zootacular had 236 guests register and 144 attended. The November FALCONERS event will be a virtual event held Novemeber in partnership with the MSU Museum. The event will be back on zoo grounds for a special Wonderland of Lights Tuesday, Dec. 8, 2020 from 5-8 p.m.

Enjoy a few comments from event participants:


- "Such a great time! Love this program."

In the month of October, 70 Zoo In Your Neighborhood passes were used with 202 guests using those passes (105 of those guests came during Fall Zootacular) compared to 325 in 2019! Zoo passes allow families free admission and parking and can be checked out at one of our 42 community partner sites. We are encouraged by these numbers since 16 of our community partners are still unable to give out zoo passes during this time or don't have the resources right now to promote them.

#### **Animal Care**

- Sivaki the male tiger had a physical to check his reproductive health as well as his overall health.
- Maliha the red panda had her yearly physical.
- Annie Marcum held outdoor cat training demonstrations for the High School class.
- Moose sarcoma case series submitted to the Veterinary Record.
- Fox pony had a very unusual protozoal infection in his neck that caused his death. This case was presented at the American Society for Veterinary Clinical Pathology (virtual due to Covid).
- Female elk Bell and Sage recently received their yearly vaccinations. The elk are being monitored for breeding this season and we hope to have elk calves in the summer.
- Jenna, our female binturong, left for a breeding recommendation at another zoo. We are in the process of bringing a new female in from another zoo to hopefully breed with our male, Barry per SSP recommendations.
- The remaining Guam Rail left this week for a SSP breeding recommendation at another zoo. We will no longer have Guam Rails at PPZ.
- The new male bongo was introduced to our females, Uzuri and Bella during the week of unseasonably warm weather, but no breeding was observed.



### Building a Sanctuary through Species Survival Plans

### Diversity, Equity, Access & Inclusion Position Statement

Approved by the AZA Board of Directors - November 2, 2020

The Association of Zoos and Aquariums (AZA) recognizes and embraces human diversity in all its forms and facets, while also acknowledging we continue to fall short in our efforts to be equitable and inclusive. We recognize that our work to conserve wildlife and wild places is inextricably linked to issues of environmental and social justice. To move forward effectively we must recognize the history of our field and the impacts of our current structures and cultures. We recognize the lasting impacts of the colonial history of the conservation and zoo and aquarium fields. We acknowledge that systemic racism is embedded in our structures, culture and organizations, and we are committed to positive and sustained change that dismantles these barriers.

AZA zoos and aquariums operate as both businesses and conservation organizations. They provide their communities with unique and valuable learning and recreation opportunities while supporting their local economies through employment opportunities, money spent in the community on goods and services, and as tourism destinations of significant economic impact. At the same time, AZA zoos and aquariums work with conservation partners around the world from a wide variety of cultures and backgrounds to save species. Therefore, it is critical that zoo and aquarium professionals recognize the importance of diversity, equity, access and inclusion in both their business and conservation practices.

AZA zoos and aquariums need to recognize the strength that comes from the diversity of backgrounds among staff, partners, and stakeholders to achieve their missions. As the composition of the United States' and other countries' populations become increasingly diverse, and calls for a more equitable society become more urgent, zoos and aquariums must take action to develop or deepen comprehensive diversity and inclusion initiatives in their hiring and employment practices; the services and experiences they provide their visitors and communities; the way that they do business; and how they work with in-situ conservation partners.

This position statement applies to the Association's offices, its employees, and its individual and organizational members. It acknowledges that accredited members must also have their own staff diversity, equity, access, & inclusion statement and program. The statement and program should be reflective of the community, region, and country in which the member operates and serves. While AZA leadership, the AZA Board of Directors and AZA Committees will continue to advance diversity, equity, access, and inclusion trends, strategies, resources and best practices for AZA, there is an expectation that all individual members, member institutions and AZA staff will proactively work toward greater diversity, equity, access and inclusion in all that they do.
