5. Financial Report YTD (preliminary) through April 30, 2023

**Revenue:** Year to date revenue at \$455,530.31 is over budget by \$95,166, with capital campaign revenue not included. Year to date revenue exceeds prior year by \$102,753.77 without the capital campaign.

**Expenses:** Year to date expenses at \$332,553 are \$4778 under budget without the capital campaign. Year to date expenses are \$68,954.07 over prior year primarily due to staffing changes.

Net surplus: There is a net deficit of \$795,547.25 with capital campaign revenue included due to a transfer of \$1,325,000 to Ingham County in February. The net surplus from operations not including capital campaign is \$99,944.07.

Cash: The days of cash increased from 328 days as of March 31, 2023 to 377 days as of April 30, 2023 with capital campaign cash and expenses not included.
